Emergency Administrative Order 30 day Extension of Emergency Protective Orders

At the Emergency Meeting on Monday, April 6, 2020, the California Judicial Council adopted Emergency Rules of the California Rules of Court. Pursuant to Emergency Rule 8(b)(1), each Emergency Protective Order (EPO-001) identified in Exhibit A to this order shall remain in effect for 30 days from the date it was issued. The final column in Exhibit A identifies the new expiration date. This order supersedes any prior orders and expiration dates for the Emergency Protective Orders identified in Exhibit A.
