**THIRD  
IMPLEMENTATION ORDER  
RE EMERGENCY ORDER  
(Gov. Code, § 68115)**

12 Exercising the authority granted by Government Code section 68115 and the April  
13 24, 2020 Order of Chief Justice Tani Cantil-Sakauye, Chair of the California Judicial  
14 Council, issued in response to the April 21, 2020 Request for a Judicial Emergency Order  
15 made by the Superior Court of Orange County (“Court”), this Court HEREBY FINDS  
16  
17 **AND ORDERS AS FOLLOWS:**

18 1. The Court declares that all dates from 4/27/2020 to 5/22/2020 are holidays for  
19 purposes of computing the time for filing papers with the Court under Code of Civil Procedure  
20 sections 12 and 12a. (Gov. Code, § 68115(a)(4).)

22 2. The Court declares that all dates from 4/27/2020 to 5/22/2020 are holidays for  
23 purposes of computing the time under:

24 a. Welfare and Institutions Code section 313 (time to release minor  
25 taken into custody pending dependency proceedings);  
26

- b. Welfare and Institutions Code section 315 (time to hold detention hearing for minor taken into custody pending dependency proceedings);
- c. Welfare and Institutions Code section 334 (time to hold hearing on dependency petition);
- d. Welfare and Institutions Code section 631 (detention of minor in wardship proceedings);
- e. Welfare and Institutions Code section 632 (detention hearing for minor in wardship proceedings);
- f. Welfare and Institutions Code section 637 (detention rehearing for minor in wardship proceedings); and
- g. Welfare and Institutions Code section 657 (hearing on petition to declare minor a ward).

3. The Court extends the time periods provided in sections 583.310 and 583.320 of the Code of Civil Procedure to bring an action to trial by sixty (60) days. (Gov. Code, § 68115(a)(6).) This request applies only to cases in which the statutory deadline otherwise would expire from 4/27/2020 to 5/22/2020, inclusive.

4. The Court extends by not more than thirty (30) days the duration of any temporary restraining order that would otherwise expire from 4/27/2020 to 5/22/2020, inclusive, because the emergency condition prevents the Court from conducting proceedings to determine whether a permanent order should be entered. (Gov. Code, § 68115(a)(7).)

5. The Court extends the time period provided in section 859b of the Penal Code for the holding of a preliminary examination from 10 court days to not more than 30 court

1 days, applicable only to cases in which the statutory deadline otherwise would expire from  
2 4/27/2020 to 5/22/2020, inclusive. (Statewide Emergency Order by Hon. Tani Cantil-  
3 Sakauye, March 30, 2020.)

4 6. The Court extends the time period provided in section 1382 of the Penal Code  
5 for the holding of a criminal trial by not more than 60 days in cases in which the statutory  
6 deadline otherwise would expire from 4/27/2020 to 5/22/2020, inclusive. (Statewide  
7 Emergency Order by Hon. Tani Cantil-Sakauye, March 30, 2020.)

9 7. The Court extends the time period provided in section 825 of the Penal Code  
10 within which a defendant charged with a felony offense must be taken before a magistrate  
11 from 48 hours to 7 days, applicable only to cases in which the statutory deadline otherwise  
12 would expire from 4/27/2020 to 5/22/2020, inclusive. (Gov. Code, § 68115(a)(8).)

14 8. The Court extends the time period provided in section 313 of the Welfare and  
15 Institutions Code within which a minor taken into custody pending dependency proceedings  
16 must be released from custody to 7 days. (Gov. Code, § 68115(a)(11).) This applies only to  
17 minors for whom the statutory deadline otherwise would expire from 4/27/2020 to 5/22/2020,  
18 inclusive.

20 9. The Court extends the time period provided in section 315 of the Welfare and  
21 Institutions Code within which a minor taken into custody pending dependency proceedings  
22 must be given a detention hearing to 7 days. (Gov. Code, § 68115(a)(11).) This applies only  
23 to minors for whom the statutory deadline otherwise would expire from 4/27/2020 to  
24 5/22/2020, inclusive.

26 10. The Court extends the time periods provided in sections 632 and 637 of the  
27 Welfare and Institutions Code within which a minor taken into custody pending wardship  
28

1 proceedings and charged with a felony offense must be given a detention hearing or rehearing  
2 to 7 days. (Gov. Code, § 68115(a)(11).) This applies only to minors for whom the statutory  
3 deadline otherwise would expire from 4/27/2020 to 5/22/2020, inclusive.

4 11. The Court extends the time period provided in section 334 of the Welfare and  
5 Institutions Code within which a hearing on a juvenile dependency petition must be held by  
6 15 days. (Gov. Code, § 68115(a)(12).) This applies only to minors for whom the statutory  
7 deadline otherwise would expire from 4/27/2020 to 5/22/2020, inclusive.  
8

9 12. The Court extends the time period provided in section 657 of the Welfare and  
10 Institutions Code within which a hearing on a wardship petition for a minor charged with a  
11 felony offense must be held by 15 days. (Gov. Code, § 68115(a)(12).) This applies only to  
12 minors for whom the statutory deadline otherwise would expire from 4/27/2020 to 5/22/2020,  
13 inclusive.


15 13. The declaration in paragraph 1 of this Order shall not apply to: (a) proceedings  
16 regarding a guardianship or conservatorship under the Probate Code; (b) proceedings  
17 pursuant to Title 7, Chapter 20 of the California Rules of Court (“Claims of Minors and  
18 Persons With Disabilities”) and (c) proceedings regarding a conservatorship under the  
19 Lanterman-Petris-Short (LPS) Act (Welfare & Institutions Code section 5150, et seq.). Such  
20 proceedings remain subject to the other provisions of this Order, to the extent applicable.  
21

22 Except as indicated in paragraph 13, it is the intent of this Order to provide the  
23 maximum length of constitutionally permitted continuance days authorized by the April 24,  
24 2020 Order issued by the Hon. Tani G. Cantil-Sakauye, Chief Justice of the California  
25 Supreme Court. Any conflicts in the above language are to be resolved in favor of granting  
26

1 the lengthier of the continuance options. The clerk's office, as well as access to the court's  
2 physical files and records shall remain closed to the general public during this time.
