- 1. In all cases where WILLIAM D. MAHONEY, Public Guardian, or JOHN S. WILLIAMS, Public Guardian, has petitioned for appointment as conservator or temporary conservator or guardian or temporary guardian of the person and/or estate of any individual and Letters have not yet issued, such Letters of Conservatorship or Letters of Temporary Conservatorship or Letters of Guardianship or Letters of Temporary Guardianship shall be issued in the name of LUCILLE LYON, Public Guardian.
- 2. In all cases where Letters of Conservatorship or Letters of Temporary Conservatorship or Letters of Guardianship or Letters of Temporary Guardianship have been issued in the name of WILLIAM D. MAHONEY, Public Guardian, or JOHN S. WILLIAMS, Public Guardian, LUCILLE LYON, Public Guardian, shall act under the authority and pursuant to such Letters without the reissuance of Letters in each case. This includes cases where the appointment was as the initial conservator, temporary conservator, guardian, or temporary guardian, and also cases where the appointment was as the successor conservator, temporary conservator, successor guardian, or temporary guardian.
- 3. In all cases where this court has made an order appointing WILLIAM D. MAHONEY, Public Guardian, or JOHN S.
