19 THE COURT, on its own motion, has taken judicial notice of the fact that JOHN S. WILLIAMS  
20 resigned as Public Administrator of Orange County effective on January 23, 2012, and that in  
21 accordance with Government Code section 27444 on such date the authority of JOHN S. WILLIAMS as  
22 Public Administrator of Orange County ceased. The court has further taken judicial notice of the fact  
23 that the Board of Supervisors of Orange County has not filled the resulting vacancy in the office of  
24 Public Administrator of Orange County, and the duties of the office are being discharged by LUCILLE  
25 LYON, Assistant Public Administrator, in accordance with Government Code section 24105. The court  
26 finds that in order to facilitate the administration of decedent estate cases presently pending before this  
27 court, it is appropriate to make and enter the orders set forth below.



IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

1. In all cases where this court has made an order appointing JOHN S. WILLIAMS, Public Administrator, as personal representative of an estate which is under the jurisdiction of this court, LUCILLE LYON, Assistant Public Administrator, may discharge the authority granted by such order in accordance with Government Code section 24105, subject to the same obligations and penalties as the Public Administrator, without the need for a new order to be issued in each case.

2. In the event LUCILLE LYON, Assistant Public Administrator, should so request, the Clerk of the Orange County Superior Court shall reissue to the ORANGE COUNTY PUBLIC ADMINISTRATOR Letters Testamentary or Letters of Administration in any matter wherein JOHN S. WILLIAMS, as Public Administrator, was previously issued such Letters, on the same terms and conditions as previously granted.
