## **TWO TRACK SYSTEM - EXPEDITED CALENDAR - INFORMATION SHEET**

### **1. INTRODUCTION**

A NEW CALENDAR SYSTEM HAS BEEN DESIGNED TO ALLOW CERTAIN MATTERS TO BE SET ON AN EXPEDITED CALENDAR. ELIGIBLE MATTERS ARE UNCONTESTED AND NON-EVIDENTIARY. WITHOUT ANY REQUEST FOR DISCRETIONARY RELIEF; SPECIFICALLY: PETITIONS TO DETERMINE SUCCESSION TO REAL PROPERTY, FINAL ACCOUNT OF DECEDENT'S ESTATE AND WAIVER OF ACCOUNT OF DECEDENT'S ESTATE. MATTERS WHICH INCLUDE A REQUEST FOR EXTRAORDINARY FEES, DETERMINATION TO ENTITLEMENT, REQUEST FOR INSTRUCTIONS OR INTERPRETATION OF A WILL SHALL NOT BE SET ON THE EXPEDITED CALENDAR.

### **2. FILING FEE (\$) DUE UPON FILING. (WHEN APPROPRIATE.)**

### **3. THE EXPEDITED CALENDARS WILL BE HEARD MON. THROUGH FRI. AT 2:30 P.M. IN DEPT. 703. PETITIONER IS TO CHOOSE A DATE, GIVE PROPER NOTICE AND SUBMIT THE DECLARATION, PETITION, NOTICE OF HEARING, ALL SUPPORTING DOCUMENTS AND ORDER FOR FILING NO LATER THAN 16 CALENDAR DAYS PRIOR TO THE HEARING DATE (AND NO EARLIER THAN 20 CALENDAR DAYS PRIOR TO THE HEARING DATE). NO SUBSEQUENT DOCUMENTS MAY BE FILED.**

### **4. EXAMINER "NOTES" WILL NOT BE MAILED AND AN EXAMINER WILL NOT BE AVAILABLE FOR QUESTIONS BY PHONE.**

### **5. COUNSEL MAY CALL THE RECORDED "RECOMMENDED FOR APPROVAL" LIST THE DAY BEFORE THE HEARING AT 935-8065 OR THE COURTROOM CLERK ON THE DAY OF THE HEARING AT 935-6050 TO VERIFY RULING.**

### **6. THERE WILL BE NO OPPORTUNITY FOR "SECOND CALL" OR FOR A REQUEST FOR CONTINUANCE.**

### **7. ORDERS ARE TO BE PREPARED IN EXACTLY THE SAME ORDER AND FORMAT AS THE PETITION AND MUST INCLUDE A METHOD FOR RETURN. CONFORMED COPIES OF ORDERS WILL BE RETURNED AS EXPEDITIOUSLY AS POSSIBLE, BY THE METHOD PROVIDED. SHOULD AN ORDER BE REJECTED, CORRECTED AND RESUBMITTED, THE ORDER WILL BE SUBJECT TO THE REGULAR CHECKING PROCEDURE.**

### **8. SHOULD THERE BE A DEFICIENCY OR OPPOSITION, THE PETITION WILL BE DISMISSED WITHOUT PREJUDICE AND A NEW PETITION MUST BE PREPARED AND SUBMITTED FOR FILING. UPON SUBMISSION, A NEW SETTING FEE (WHEN APPROPRIATE) WILL BE REQUIRED AND THE MATTER WILL BE SET ON A "REGULAR " CALENDAR.**
