



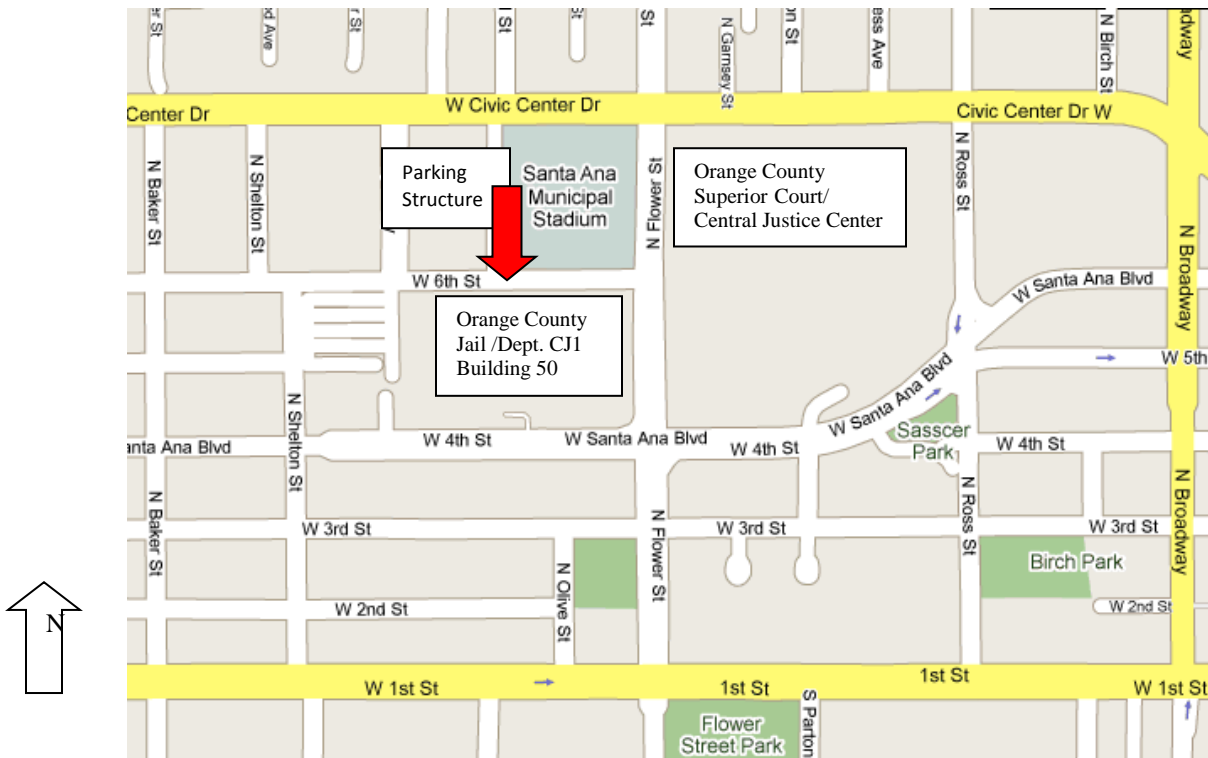

**Are you in Court today to see someone who was arrested?**

Beginning on October 28, 2009, persons arrested on a new violation or warrant may be heard in Department CJ1 at the Orange County Central Men’s Jail. The Department CJ1- Public Viewing Area is located at the Orange County Jail Intake and Release Center at **550 N. Flower St. Building 50, Santa Ana, CA 92703**. Parking is available in the stadium parking structure, adjacent to the jail. Select “E-Services” – “Who’s in jail” and enter inmate information.

Note: The entrance to the building is located off of 6<sup>th</sup> street directly across from the stadium parking structure.
