### **COURT CLOSURE INFORMATION**

The Superior Court of Orange County will be closed the third Wednesday of each month beginning September 16, 2009, through June 16, 2010. The California Judicial Council approved the unprecedented one-day-a-month closures for all state courts due to California's fiscal crisis and the Legislature's reduced state funding to the courts.

The statewide court closures are authorized by recently enacted Government Code section 68106. Court closure days listed below will not count as official court days for purposes of calculating statutory deadlines. The Court will re-set hearings currently scheduled for these dates. As with all non-court days, judges will be on duty to handle emergency matters.

FRIDAY AFTERNOONS AT 3:00 PM  
Beginning November 6, 2009**

Only Limited Emergency Services will be Available

The Superior Court of Orange County will close courtrooms and public service areas every Friday at 3:00 pm beginning November 6, 2009.

- Only limited emergency services will be available from 3:00 pm to 5:00 pm on Fridays.
- For most matters, in-person services will NOT be available after 3:00 pm to 5:00 pm on Fridays.
- Traffic citations may be paid online at [www.occourts.org](http://www.occourts.org) or at a court drop box.
- Drop boxes or door slots are located at each justice center for filing papers and submitting payments. Properly completed documents placed in drop boxes before 5:00 p.m. will be considered received on the closed date.

Despite the reduced hours, it is a court day, and all statutory time limits and due dates apply.
