Dear Orange County Residents,

I am pleased to present to you the Fiscal Year (FY) 2014-15 Approved Budget for the Superior Court of California, County of Orange.

FY 2014-15 represents the second consecutive year of minimal funding restoration for the California Judicial Branch (Branch) with the Governor providing an additional \$129.1 million in funding; however, it still falls short of the over \$600 million needed statewide to achieve full reinvestment in the Branch.

The Court is also facing further local funding reductions due to the implementation of the Judicial Council's Workload-Based Allocation and Funding Methodology (WAFM). FY 2014-15 marks the second year of a phased-in approach to implementing WAFM. For Orange County, this translates to a net loss of roughly \$3.2 million in historical base funding and \$4.2 million less in new money (since FY 2013-14). This loss in funding, coupled with receiving only 67% of the funding needed to cover benefit cost increases and an additional reduction of \$1.8 million to cover an anticipated revenue shortfall in the Trial Court Trust Fund (the source of the base allocation), results in the Court using the remainder of its reserves to balance the FY 2014-15 Budget.

The approved budget for the Court includes revenues of \$194.5 million and expenses of \$202.9 million, resulting in the need to exhaust \$8.4 million in reserves to balance the budget. Furthermore, the Court is anticipating that it will need to implement additional expenditure reductions to balance the FY 2015-16 budget.

The Court will continue to voice its financial and justice service needs to seek ongoing solutions to these challenging issues.

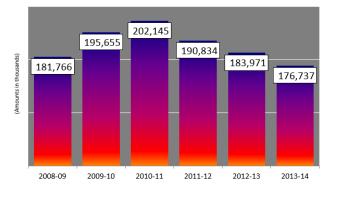

## **REVENUE COLLECTED** THROUGH THE COURT

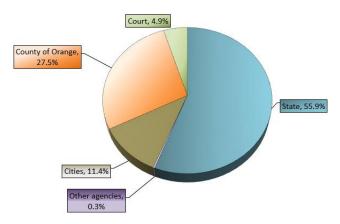

### **TOTAL REVENUE** FROM FINES AND FEES

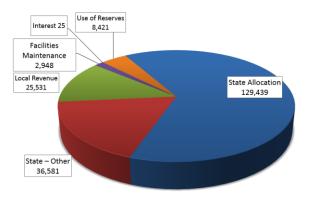


#### **DISTRIBUTION OF FINES AND FEES**

### FY 2014-15 REVENUE SOURCES



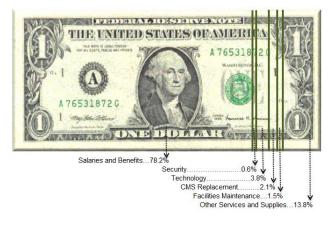

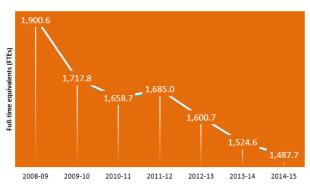

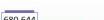

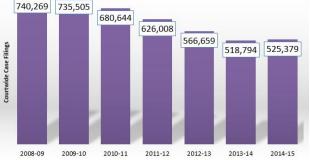
