Per Government Code Section 68084.1 "Except as otherwise provided by law, any money, excluding restitution to victims, that has been deposited with a superior court, or that a superior court is holding in trust for the lawful owner, in a court bank account or in a court trust account in a county treasury, that remains unclaimed for three years shall become the property of the superior court if, after published notice pursuant to this section, the money is not claimed or no verified complaint is filed and served."

Any unclaimed money after December 1, 2012, will become the property of the Superior Court of California, County of Orange, pursuant to Govt. Code Section 68084.1.
