



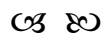

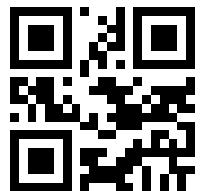

Self-represented litigants may present documents for filing in person, via mail or via electronic filing. Electronic filing is mandatory for litigants represented by an attorney, unless submitted with a fee waiver application or an electronic filing exemption order. All forms must be typed or printed legibly and, unless filed electronically, submitted in duplicate; an original and at least one (1) copy. The court's address is:

- DOCUMENTS:** If the petitioner is not represented by an attorney, the petitioner's name, address and telephone number must be typed or printed legibly in the upper left corner of each document. The petition must be signed by each adult who is applying for a change of name and/or gender using that person's present legal name. Please review your documents before filing to ensure that information like the caption, current name and proposed new name match exactly on all documents.

5. **EFFORTS TO LOCATE NON-PETITIONING PARENT:** Before requesting an order to publish the Notice of Hearing you must make an effort to locate and serve the non-petitioning parent either:

- a. personally, pursuant to Code of Civil Procedure Section 415.10 or,
- b. if the parent resides outside of California, by mail with return receipt requested, pursuant to Code of Civil Procedure Section 415.40.

If you are able to serve the non-petitioning parent by personal service, proof of service of the Order to Show Cause of Notice of Hearing must be filed with the court no later than 30 days before the hearing. Proof of service by mail must be filed no later than 40 days before the hearing.

The declaration detailing these efforts must be attached to your Application and Order for Publication of Notice of Hearing to Non-Petitioning Parent. Optional Form *MC-050 Declaration* is provided in this packet for this purpose. Suggestions for locating the parent are listed below. Please note that this list is not comprehensive.
