Dear Reader:

In 2020, COVID-19 and public health restrictions impacted the Orange County Juvenile Justice Commission (JJC). In a typical year, the JJC would have interviewed staff and inspected all Orange County juvenile institutions, selected Orange County law enforcement agencies (LEAs), and all privately operated Short Term Residential Therapeutic Programs (STRTPs). These inspections and interviews permit the JJC to evaluate the physical premises and assess staff competence and adherence to state and local mandates.

Since it was impossible to conduct in-person inspections in 2020, the JJC conducted video interviews. Through these interviews, the JJC was able to assess operations and evaluate policies and procedures. We have included a section of this Annual Report on what we believe to be the best practices in institutions, LEAs, STRTPs and schools.

The year 2020 was the third year of the JJC Essay Contest. With the cooperation of the Orange County Probation Department and the Orange County Department of Education, youth from Juvenile Hall, the Youth Guidance Center and the Youth Leadership Academy submitted 44 essays on "My Time."

As always, we thank Orange County Juvenile Court Presiding Judge Motoike for her help and support. We also thank our Executive Administrative Assistant, Susan Korean, for her tireless work on behalf of the JJC.

We hope our 2020 Annual Report will help you understand the Commission's work and the profound responsibility we all have for our children's well-being.

# COMMUNITY OUTREACH: 2020 Essay Contest

The third annual essay contest conducted by the Juvenile Justice Commission (JJC) was handled very differently due to the COVID pandemic which restricted all in-person gatherings or meetings. As a result, the contest had to be held remotely employing a Zoom virtual meeting format. Coordinated by the Probation Department, the winning students, parents, teachers, Juvenile court Judges, Orange County Department of Education (OCDE) representatives, Commissioners and other key people were connected on November 17, 2020. The Zoom meeting lasted for approximately 1 ½ hours with a total of 55 participants. Each of the Honorable Mention winners read their essays, followed by the 3rd, 2nd, and 1st place winners. The Orangewood Foundation again generously contributed to the awards.

There were 44 essays submitted by students at the Otto Fischer School serving Juvenile Hall and the Youth Leadership Academy, and the Rio Contiguo High School which serves the Youth Guidance Center. The teachers provided the guidance for the students to complete their submissions entitled "My Time". The essays were reviewed by the JJC Essay Committee members and ranked. Once again, it was a very difficult task to select the winners among the many profound and deeply personal stories. In spite of the adaptations due to COVID restrictions, the celebration still provided a meaningful experience for the students, staff and court officials.

In YGC, I see life in a different perspective. I'm working on myself and I have come to change my street mentality to a more mature perspective.

# COMMUNITY OUTREACH: THIS YEAR'S INSPIRING ACCOMPLISHMENTS

A reoccurring theme throughout 2020 was the impact of the heroes that emerged during the COVID crisis. Numerous news stories identified individuals who performed 'above and beyond' including first responders and other civic minded organizations or agencies. Although the JJC's in-person inspections and attendance at meetings and other functions were halted by the pandemic, the Commissioners still witnessed several examples of noteworthy accomplishments, including the following:

- Implementing California's first distance-learning education model for incarcerated youth
- Assembling comprehensive juvenile detention discharge packets given to all youth
- Overcoming the technological challenges to coordinate the Essay Contest Awards Ceremony
- Creating a socially distant high school graduation ceremony that was held in a church's parking lot
- Enhancing collaboration between agencies to address the remote learning and visitation needs of youth in our institutions
- Providing advanced computer programs to connect youth with families; and using those same programs to enable the caregivers to become tutors for the youth who couldn't attend classes

And, the JJC would like to recognize all of the other caregivers, institution and STRTP staffers, educators and law enforcement officers who provided exceptional service to system-involved youth during this difficult year.

#### INSPECTIONS OF COUNTY-ADMINISTERED JUVENILE INSTITUTIONS

Each year the Juvenile Justice Commission, as mandated by the Welfare and Institutions Code, inspects the four facilities that provide residential care and services for those children/youth who are part of the Juvenile Justice System. The purpose of the inspections is to ensure that high quality and appropriate care is being provided. Each of the facilities provides an accredited school program staffed by the Orange County Department of Education so that education is not interrupted by the time in residence. Each facility also has medical staff on site to address any medical needs. Children and youth also have access to behavioral health care.

Despite the COVID restrictions this year, the JJC was still able to conduct in-person interviews with youth in Juvenile Hall and the Youth Guidance Center while practicing health protocols. The remainder of the inspections were conducted virtually.

# Orange County Juvenile Hall On-line Interview: November 18, 2020

- Juvenile Hall is a Probation maximum security facility for male and female youth who have committed serious offenses in the community.
- Treatment options include Anger Management, Conflict Resolution, Substance Abuse and others.
- One-on-one counseling is provided.
- Family Reunification efforts are provided as appropriate.





# Youth Leadership Academy On-Line Interview: October 21, 2020

- The Youth Leadership Academy is a secure Probation program for males only.
- This program is short term focusing on the youth's smooth transition back into the local community.
- Treatment options include one-on-one therapy addressing Substance Abuse, Gang Prevention, and Aggressive Behavior; Group Therapy; and Family and Crisis Counseling.

# Youth Guidance Center On-Line Interview: October 29, 2020

- The Youth Guidance Center is a secure Probation four dormitory campus that includes a gymnasium and outdoor recreation fields.
- This program is for male and female residents aged 14 to 18.
- Substance Abuse is the treatment focus.
- There is also an emphasis on career readiness and occupational skill assistance.





# Orangewood Children and Family Center On-Line Interview: October 7, 2020

- Orangewood Children and Family Center is a Social Service cottage campus serving Court dependents.
- This program serves both males and females from birth to age 18.
- The length of stay is intended to be 10 days or less.
- The goal is to return the dependent to family or, if that is not possible, to locate a suitable placement.



#### INSPECTIONS OF OC LAW ENFORCEMENT AGENCIES

The JJC is mandated to inspect all law enforcement facilities where a minor is held in secure detention for any length of time and those where a minor is held in non-secure detention for 24 hours or more. No facility, other than the Probation-run institutions, holds minors for more than 24 hours. The JJC exceeds state law mandates by inspecting all facilities where a minor is held in non-secure detention for 6 hours or more. Due to COVID-19 Restrictions, in 2020, inspections were conducted as online interviews with administration at each agency. Listed below are all OC law enforcement facilities operated by police or sheriff departments with their recent statistics on detention of minors. 2020 inspection dates are listed for those that met inspection criteria. The JJC inquired about topics such as human trafficking of minors, the role of School Resource Officers, community youth programs, compliance with COVID-19 protocols and interactions with Probation and Social Services.

### **Orange County School Threat Assessment Team (OCSTAT)**

The Sheriff's School Mobile Assessment and Resource Team (SMART) presented on the importance of threat assessment in schools to avoid the tragedy of an active shooter. With an overview of the US Secret Service and Department of Education publication on threat assessment, the team explained how this program works to foster good relationships between students and School Resource Officers. Included in the presentation were current examples on threats via social media and the mindset of youth when engaged in online activity.



### **County of Orange Office of Independent Review**



Sergio Perez introduced himself and gave a presentation on The Office of Independent Review (OIR). As the Executive Director, Mr. Perez and his team work to ensure that the needs of the community and the County of Orange are met by providing accountability in the performance and operations of the following County Departments: OC Sheriff, Probation, District Attorney, Public Defender and Social Services Agency. He explained that the OIR monitors and reviews specific incidents, identifies systemic issues, and assists in developing and assessing corrective actions that address high risk practices related to the departments it oversees.

### **Orange County Probation Department**

Steve Sentman, Chief Probation Officer Bryan Prieto, Chief Deputy Probation Officer

Probation Chief Steve Sentman gave the JJC an update on SB 823 (DJJ Realignment) effective July 2021. The Bill will transfer the responsibility for the custody, treatment and supervision of youth to the counties. Orange County is preparing for this transition by dedicating housing and programs at Juvenile Hall for qualified youth who may remain in custody up to age 25.

Probation Deputy Chief Bryan Prieto thanked the JJC for coordinating the annual Essay Contest that took place on November 17, 2020. He participated in the Zoom conference call during which the winners read their winning entries.



### **OC Social Service Agency**

Anne Bloxom, Director for Children and Family Services



Anne Bloxom gave a presentation on how her department has successfully provided both in-person and virtual programs, services and trainings in compliance with COVID pandemic social distancing regulations. She provided the JJC with updates on how OCSSA is implementing recent legislation affecting foster youth including: the new Family Urgent Response (FURS) program, the revised Foster Youth Bill of Rights, and the mandatory reproductive health training for staff. She also discussed the agency's procedures in cases involving youth with drug use issues including the availability of Narcan/Naloxone.
