# **COMMENTS BY JUVENILE COURT**

Melissa Del Rio, Court Operations Manager gave a brief introduction of the new Executive Administrative Assistant, Lii Toelupe, and the Legal Processing Specialist, Taeona Beechum who will be the support staff to the Juvenile Justice Commission. She also reported that Judge Swain is joining the Juvenile Panel and will be training with Judge Apkarian.

#### **COMMENTS BY DISTRICT ATTORNEY**

Jeff Kirk, District Attorney, reported they are currently down 80% in truancy filings.

# **COMMENTS BY PUBLIC DEFENDER (JUVENILE JUSTICE)**

Arlene Speiser, Public Defender, reported there has been an increase in mental health filings.

# COMMENTS BY PUBLIC DEFENDER (JUVENILE DEPENDENCY)

Seth Bank, Public Defender reported there has been an increase in dependency filings.

#### **COMMENTS BY COUNTY COUNSEL**

Dana Stits, Supervising Deputy, reported there has been a 3% increase in petition filings. He also shared that of the 12 attorneys in his office half of the attorneys have been in the office for less than one year.

#### COMMENTS BY ORANGE COUNTY PROBATION DEPARTMENT

Probation Chief, Daniel Hernandez, reported they are piloting a new emergency alert monitor that will alert staff when a youth's heart rate increases or decreases. Chief Daniel Hernandez also reported that all probation officers are trained and certified to carry Narcan, and Fentanyl testing is now part of their panel testing. He also shared that they have not yet filled the Deputy Chief of Probation position.

# COMMENTS BY ORANGE COUNTY SHERRIFF DEPARTMENT

Commander Jerrod Dahl reported they had 1,729 5<sup>th</sup> and 6<sup>th</sup> grade students from 22 schools, graduate from their Above the Influence program. Commander Jerrod Dahl also reported that they held 13 Fentanyl awareness assemblies for over 14,000 students.

# **COMMENTS BY SOCIAL SERVICES AGENCT (SSA)**

Mahonri Sapiga, Administrative Manager, Orangewood Children & Family Center (OCFC) reported that they are working towards decreasing the number of appeals they receive regarding ICWA findings. He reported that they have 70 vacancies in the social worker classification. They are recruiting using virtual hiring which has been quite successful.

# COMMENTS BY HEALTH CARE AGENCY, CHILDREN & YOUTH BEHAVIORAL HEALTH

Alicia Lemire, Program Manager, reported they opened their 7<sup>th</sup> outpatient treatment facility. Alicia Lemire also reported that Narcan is now available at all county facilities. They will continue to encourage NARCAN at the STRTPs.

# COMMENTS BY HEALTH CARE AGENCY, JUVENILE HEALTH SERVICES

Grace Lizardo, Program Manager, reported they have had a decline in the number of positive COVID cases. Grace Lizardo also reported that upon a youth's discharge, family members and caretakers are given two doses of Narcan and a two-minute instruction on how to administer Narcan.

# COMMENTS BY CALIFORNIA COMMUNITY CARE LICENSING

Ann Valenzuela, Licensing Program Analyst, provided a brief update on obtaining waivers to have Narcan in STRTPS.

# COMMENTS BY DEPARTMENT OF EDUCATION, INSTITUTIONAL SCHOOLS

Griselda Velasco, Program Specialist, reported they are working with four transitional liaisons to assist seniors with FAFSA. Griselda Velasco also reported that they are coordinating with the Law Offices of Harold Laflamme regarding truancy.

Vern Burton, Assistant Superintendent, Access Schools, Department of Education Institutional Schools provided an update on the new staff helping with in-custody classroom instruction including a tutor for students in the classroom.

# COMMENTS BY REGIONAL CENTER OF ORANGE COUNTY

Jack Stanton, Regional of Orange reported they have had a decrease in child age children due to their population of children aging out of the specific services they provide.

#### **COMMENTS BY WAYMAKERS**

Hether Benjamin, Chief Program Officer reported they recently had their 50<sup>th</sup> anniversary and have recently been focusing on the Human Trafficking Task Force.

#### **COMMENTS BY CASA**

Jenny Leon, Chief Program Officer reported for the year 2023 they are trying to reach a goal of servicing 950 youth. Jenny Leon also reported they currently have a waiting list of 270 youth. They are physically moving offices to the city of Orange.

# COMMENTS BY PROJECT YOUTH - ORANGE COUNTY (OC)

Nazly Restrepo, Associate Director, reported that six youth who are in the ICAN! (Independence, Competence, Aptitudes Now!) workshop program have become employed. They reported serving 1,500 families.

# COMMENTS BY LAW OFFICES OF HAROLD LAFLAMME (MINOR'S COUNSEL)

Mari Duque, Program Specialist reported they are having an upcoming meeting on February 8<sup>th</sup>, 2023, with the Department of Education to discuss how they can collaborate with each other on truancy issues. They noted that the youth filings are on the rise, but something they were expecting after COVID.
