She continuously encourages and assists minors in the best way possible to have a safe return to their placement.

Mahonri Sapiga will continue to keep the JJC updated on their progress.

# NEW BUSINESS INSPECTIONS

Commissioner Perring reported STRTP, law enforcement agencies and institution inspections will begin the 2<sup>nd</sup> week in April. Commissioner Garfias suggested that Commissioner Perring discuss the inspection process at the next JJC meeting on April 5, 2023.

#### REPORTS FROM STANDING COMMITTEES & WORKING GROUPS

#### A. EDUCATION

Commissioner Vachet provided an overview of the YGC meeting held on March 10, 2023. She reported a new assistant director has been appointed. Also, a new school system for reviewing school transcripts was developed. Some progress has been made and the JJC education sub-committee will continue to provide updates. EAA to schedule a follow-up meeting with Jim Perez and Erick Bieger regarding YGC.

## **B. JJC/Probation Book Club**

Commissioner Crowley reported the book club held a congratulatory event in honor of finishing their first book. With the success of the first book club, a 2<sup>nd</sup> group was created. A possible partnership with Project Youth to assist with funding was also mentioned.

Commissioner Winder gave an overview of the MHSA meeting held on February 27, 2023. Commissioner Winder reported there is a need to provide children and youth with mental health services.

Commissioners Crowley and Perring shared an overview of the CWISP meeting held on March 2, 2023. Commissioner Perring reported Social Services is having trouble hiring for social work services. HCA is working towards having Narcan available.
