COMMENTS BY JUVENILE COURT

Melissa Del Rio, Court Operations Manager provided a brief update. Judge Swain is now covering Department L33 for Judge Keough.

COMMENTS BY DISTRICT ATTORNEY

Katie David, Deputy District Attorney, stated she is newly assigned and gave a brief introduction.

COMMENTS BY PUBLIC DEFENDER (JUVENILE JUSTICE)

Arlene Speiser, Public Defender, reported that mental health challenges among the youth population, but they continue to provide paralegal and resource support to families. Arlene Speiser also reported Richard Chung is the new attorney supervisor for Juvenile Dependency.

COMMENTS BY COUNTY COUNSEL

Dana Stits, Supervising Deputy, reported it has been a challenge recruiting for Dependency, but currently hired four law students as interns.

COMMENTS BY ORANGE COUNTY PROBATION DEPARTMENT

Probation Chief Daniel Hernandez reported their youth council has shown great success in planning and organizing events. Chief Hernandez also reported that they are acquiring mobile reporting vehicles to help youth with transportation to regional offices.

COMMENTS BY ORANGE COUNTY SHERIFF'S DEPARTMENT

Commander Kirsten Monteleone reported their SMART (School Mobile Assessment Resource) Team has responded to 74 school threat assessments between 2018-2019 and they continue to hold monthly meetings at schools about child safety.

COMMENTS BY SANTA ANA POLICE DEPARTMENT

Chief David Valentin reported no current updates.

COMMENTS BY SANTA ANA SCHOOL POLICE DEPARTMENT

Chief Sergio Mancilla reported they have an upcoming CAST (Child Abuse Services Team) review. They are also looking to collaborate with the CSEC (Commercially Sexually Exploited Children) team.

COMMENTS BY SOCIAL SERVICES AGENCY (SSA)

Jyothi Atluri, Director of Family Services, and Kristi Fiskum, Deputy Director of Children & Family Services reported SSA is working towards providing placement stability. They also currently have an on boarding court training program for new social workers.

Mahonri Sapiga, Administrative of Orangewood Children & Family Center reported they currently house 65 youth. They are working with probation to help with the increased number of away from care incidences. Mahonri Sapiga also reported the clinical evaluation and guidance unit (CEGU) has been very helpful in hosting classes on self-care and mental health.

COMMENTS BY HEALTH CARE AGENCY, CHILDREN & YOUTH BEHAVORIAL HEALTH

Alicia Lemire, Division Manager, provided a brief update and reported they currently have 7 substances abuse intensive outpatient treatment facilities.

COMMENTS BY HEALTHCARE AGENCY, JUVENILE HEALTH SERVICES

Grace Lizardo, Program Manager, reported they are currently testing for COVID on intake and post visit. They are also providing an in-service on Narcan and Opioid use to youth who are 12 years and older.

DEPARTMENT OF EDUCATION INSTITUTIONAL SCHOOLS

Raina Lee reported Foster Youth held their 14th annual college career fair. In attendance were youth from Orangewood and STRTP's.

Vern Burton, Assistant Director, reported a new coordinator to start by July 2023.

COMMENTS BY CASA

Jenny Leon, Chief Officer, reported CASA is hosting a conference on June 24, 2023, with keynote speaker David Ambrose.

<u>COMMENTS BY PROJECT YOUTH - ORANGE COUNTY (OC)</u>

Nazly Restrepo, Social Director reported Project Youth will collaborate with local community partners to host their 2nd Youth Resource Fair on June 22, 2023.

COMMENTS BY LAW OFFICE OF HAROLD LAFLAMME - YOUTHS COUNSEL

Mari Duque, Executive Director provided a brief update and reported 3 new attorneys have been hired. Their goal is to have a least two attorneys per courtroom.
