APPROVAL OF MINUTES

The November 16, 2022 minutes were approved by unanimous consent.

GUEST SPEAKER

Sanford Rose, OC Juvenile Hall – Division Director, provided updates about Juvenile Hall and the various activities that have taken place. He shared that the Multipurpose Rehabilitation Center (MRC) is open and in use. He mentioned that the check-in system was recently upgraded. Mr. Rose shared that an article was published by the Daily Pilot favoring efforts of the OC Juvenile Hall in establishing opportunities for youth to be engaged in youth councils to plan activities such as a Haunted House, Water Activity Day, Friendsgiving, and a Talent Show. Lastly, Mr. Rose shared that Probation will be involved in three new builds: YGC Transitional Center, Transitional apartments and with SB823 a long-term living unit.

CORRESPONDENCE

The correspondence was reviewed.

The Executive Administrative Assistant provided the response to the CAN letter from Olive Crest – Wheeler STRTP. No further action is requested by the Commission.

Commissioner Vachet discussed Education concerns regarding YGC teachers and the lack of administrative oversight. Commissioner Johnson suggested that Judge Arthur be made aware of the situation. Commissioner Vachet reminded the group that education is mandated to be provided for youth in custody.

Commissioner Vachet provided an update on the 2022 Essay Contest with Probation youth funding. The Court will not be able to receive the funds from Supervisor Foley's office. Supervisor Foley's office will work with a non-profit organization, Project Youth, for reimbursement for this year's essay contest expenses and funding for the future.

Commissioners Crowley and Perring provided a brief update and indicated more information will be forthcoming on the SB 823 subgroups (Education and System Navigator/Peer Mentor/Credible Messenger/Re-Entry-Scope of Work Discussion).

Commissioner Crowley discussed a pilot program book club that she would be interested in implementing at Juvenile Hall in Unit Tango. She shared with the commissioners what she envisioned and requested the approval of the commissioners. All commissioners agreed to this activity.
