#### UPDATE - REMOTE & IN PERSON HEARINGS

### Do you have an in-person evidentiary (a proceeding with oral testimony) hearing or trial scheduled and would like to appear remotely?

California Rules of Court and Code of Civil Procedures allows for parties to submit notice of intent to appear remotely for evidentiary hearings and trials.

- ✓ Complete Judicial Council form <u>RA-010 Notice of Remote Appearance.</u> You must serve all parties with this form.
  - Page 3 of the form has instructions
- ✓ Complete Judicial Council form RA-020 Order Regarding Remote Appearance.
- ✓ Submit the forms to the court
  - o Filing information can be found on the court's website, click this link

## Do you want to oppose a remote evidentiary (a proceeding with oral testimony) hearing or trial?

California Rules of Court, rule 3.672(h)(3) state in response to notice of remote proceeding for an evidentiary hearing or trial by a party or the court and/or to obtain a court order for in-person appearance, a party may submit their opposition and serve the other parties and the court.
