NAME CHANGE NOTICE OF RELATED CASES (Mandatory form)  
Code of Civil Procedure 1275 et seq., Health and Safety Code 103430, 103425, 103435,  
and 103440**


IT IS ORDERED that, effective January 2, 2020, a completed *Name Change Notice of Related Cases* form must be filed with one of the following Judicial Council Petitions:

- Petition for Name Change (NC100)
- Petition for Change of Name, Recognition of Change of Gender, and issuance of New Birth Certificate (NC-200)
- Petition for Recognition of Change of Gender and For Issuance of New Birth Certificate (NC-300)
- Petition for Recognition of Minor's Change of Gender and Issuance of New Birth Certificate and Change of Name (NC-500)

At the direction of the Civil and Family Law Supervising Judges, name changes and name/gender changes involving 1) minors or 2) adults with a prior family law case, will be filed at Lamoreaux Justice Center. Gender changes involving minors will also be filed at Lamoreaux Justice Center. A new *Name Change Notice of Related Cases* mandatory local form was created for this purpose.

The Court hereby delegates authority to the clerk's office personnel to reject filings which do not include the new *Names Change of Related Cases* mandatory local form.
