Are you in Court today to see someone who was arrested?

Beginning on October 28, 2009, persons arrested on a new violation or warrant may be heard in Department CJ1 at the Orange County Central Men's Jail. The Department CJ1- Public Viewing Area is located at the Orange County Jail Intake and Release Center at **550 N. Flower St. Building 50, Santa Ana, CA 92703**. Parking is available in the stadium parking structure, adjacent to the jail. For more information on where a defendant will be heard, please check the Orange County Sheriff's Department website at www.ocsd.org. Select "E-Services" – "Who's in jail" and enter inmate information.

Note: The entrance to the building is located off of 6th street directly across from the stadium parking structure.

Central Justice Center

700 Civic Center Dr. West Santa Ana, CA 92702

- Start out going west on CIVIC CENTER DR W toward N FLOWER ST- 0.1 mi
- 2. Turn left onto N FLOWER ST- 0.2 mi
- 3. Arrive at 550 N FLOWER ST

North Justice Center

1275 North Berkeley Avenue Fullerton, CA 92832

- Start out going south on N BERKELEY AVE toward N HARBOR BLVD – 0.3 mi
- 2. Turn right onto N HARBOR BLVD 1.4 mi
- 3. Turn left onto **E ORANGETHORPE AVE** 0.3 mi
- 4. Turn right onto **S LEMON ST/N LEMON ST** continue to follow **S LEMON ST** 0.4 mi
- 5. Merge onto **CA-91 E** via the ramp on the left 2.2 mi
- 6. Merge onto the **CA-57 S** toward **SANTA ANA** 4.8 mi
- 7. Take the **I-5 S** exit on the left 1.3 mi
- 8. Take the MAIN ST SOUTH exit 0.2 mi
- 9. Merge onto N MAIN ST 0.5 mi
- 10. Turn right onto **W 17 TH ST** 0.5 mi
- 11. Turn left onto N FLOWER ST 0.8 mi
- 12. Arrive at 550 N FLOWER ST

Harbor Justice Center – Newport Beach

- Start out going southwest on JAMBOREE RD toward BIRCH ST.-0.7 mi
- 2. Turn Right onto MACARTHUR BLVD- 3.6 mi
- 3. Turn Right onto **S MAIN ST**-3.1 mi
- 4. Turn Left onto W 1 STST-0.5 mi
- 5. Turn Right onto **N FLOWER ST** 0.2 mi Arrive at **550 N FLOWER ST**

West Justice Center

8141 13th Street Westminster, CA 92683

- Start out going west on 13 TH ST toward BEACH BLVD/CA-39 N -0.1 mi
- 2. Turn right onto BEACH BLVD/CA-39 N 0.9 mi
- 3. Merge onto **CA-22 E** 6.0 MI
- 4. Take the I-5/CA-57/THE CITY DR exit, EXIT 14 toward BRISTOL ST 0.6 mi
- 5. Take **EXIT 14B** toward **BRISTOL ST** 0.2 mi
- 6. Take the **BRISTOL ST** ramp -0.1 mi
- 7. Turn left onto **N BRISTOL ST** 1.3 mi
- 8. Turn left onto **W 17TH ST** 0.5 mi
- 9. Turn right onto N FLOWER ST 0.8 mi
- 10. Arrive at 550 N FLOWER ST

Lamoreaux Justice Center

- 1. Start out going south on **THE CITY DR S** toward **JUSTICE CTR** 0.1 mi
- 2. Turn right onto JUSTICE CTR 0.1 mi
- 3. Turn left onto the CITY DR S -0.7 mi
- 4. Turn left onto **W MEMORY LN** 0.4 mi
- 5. Turn right onto **N BRISTOL ST** 0.9 mi
- 6. Turn left onto W 17 TH ST -0.5 mi
- 7. Turn right onto **N FLOWER ST** 0.8 mi
- 8. Arrive at 550 N FLOWER ST
