Exercising the authority granted by Governor Gavin Newsom’s Executive Order N-38-20 and the March 30, 2020 Statewide Emergency Order of Chief Justice Tani Cantil-Sakauye, Chair of the California Judicial Council, and in addition to the measures the Superior Court of Orange County (“Court”) instituted in its March 27, 2020 Second Implementation Order, this Court **HEREBY FINDS AND ORDERS THE FOLLOWING ADDITIONAL MEASURES:**

1. The Court extends the 10 court day period provided in Penal Code section 859b for the holding of a preliminary examination and the defendant’s right of release to 30 court days.
2. The Court extends the time period provided in Penal Code section 825 for the time in which a defendant charged with a felony offense shall be taken before a magistrate from 48 hours to 7 days.

1 3. The Court extends the time period provided in Penal Code section 1382 for the
2 holding of a criminal trial by 60 days from the last date on which the statutory deadline
3 otherwise would have expired.

4 4. The Court extends the time periods provided in Code of Civil Procedure
5 sections 583.310 and 583.320 to bring an action to trial by 60 days from the last date on which
6 the statutory deadline otherwise would have expired.

7
8 5. The Court clarifies that the 60-day continuance of jury trials, authorized by the
9 March 23, 2020 order by the Chief Justice, and the March 27, 2020 Second Implementation
10 Order, is to be calculated from the date for which the trial was set or extended as provided in
11 section 3 or 4 above, whichever is longer.

13 6. The Court also declares that it will make use of available technology, when
14 possible, to conduct judicial proceedings and court operations remotely, suspend any rule in
15 the California Rules of Court to the extent such rule would prevent the Court from using
16 technology to conduct judicial proceedings and court operations remotely, in order to protect
17 the health and safety of the public, court personnel, judicial officers, litigants, and witnesses.

19 It is the intent of this Order to provide the maximum length of constitutionally
20 permitted continuance days authorized by the March 30, 2020 Statewide Emergency Order
21 issued by the Hon. Tani G. Cantil-Sakauye, Chief Justice of the California Supreme Court.
22 Any conflicts in the above language are to be resolved in favor of granting the lengthier of the
23 continuance options. To the extent that any provision of this Supplemental Order conflicts

1 with any provision in the Court's Second Implementation Order, this Supplemental Order will
2 supersede the provisions of this Court's March 27, 2020 Second Implementation Order.
