Foster Family Agency (FFA) Quarterly Forum

Commissioner Churchill attended the FFA Quarterly Forum on November 20, 2024. She reported on a few new requirements for foster family homes. One of the requirements allows for security cameras at the homes except in private places such as restrooms and bedrooms. The security

cameras are set up primarily for the safety and security of the youth and majority of the time set up outside of the home. She also mentioned that foster homes must be open to serve the SOGIE (Sexual Orientation, Gender Identity, and Expression) community. Commissioner Churchill stated that another topic of interest was on the portability between foster family agencies and the County.

Ribbon Cutting Ceremony at Orangewood Children and Family Center (OCFC)

Commissioners Churchill and Perring attended the Ribbon Cutting Ceremony at OCFC on November 22, 2024. Commissioner Churchill reported that the ribbon cutting ceremony was held to celebrate the completion of a project between Orangewood and OCDE, designed to enhance family visitations. The space included places to cook, play games, nursery area, art and craft space and symbolized a home like setting.
