**How to File the Petition for Change of Name**

**1. When You Must File a Name Change in Family Court:**

➤ **Filing on behalf of a child:**

If you are seeking to change the name of a minor child; or

➤ **Filing on your own behalf with a pending or past Family Law case:**

If you are seeking to change your name and you **have or had a family law case in Orange County**, the Petition for Change of Name must be filed at the Lamoreaux Justice Center in Orange (Family Court). Please contact Self-Help Services for filing options or instructions.

- A Family Law case includes Divorce, Legal Separation, Nullity, Parentage (when parents are not married) Custody and Visitation, Domestic Violence Restraining Orders, or Child Support.
- Even if your case is “closed” because you reached a judgment or an agreement with the other party in your case, you must file the Petition for Change of Name at the Family Court in Orange County.

2. Petition for Change of Name: NC-100
3. Attachment to Petition for Change of Name: NC-110
4. Order to Show Cause for Change of Name: NC-120
5. Decree Changing Name: NC-130

  - Completed and filed **after** documents have been served. This form is not necessary when both parents are filing a Petition for Change of Name on behalf of their minor child.

- A filing fee of \$435 will be charged to file a Name Change with the Family Court in Orange County, unless you qualify for a fee waiver. To apply for a fee waiver, complete a *Request to Waive Court Fees* (form FW-001) and an *Order on Court Fee Waiver* (form FW-003). If both parents are filing a Petition for Change of Name on behalf of their minor child, both parents need to complete and submit their own fee waiver forms. **2. When You Must File a Name Change in Civil Court:**

➤ **Filing on your own behalf:**

If you are seeking to change your own name and **DO NOT** have or have not had a Family Law case in Orange County.

You will need to file your forms at the Central Justice Center in Santa Ana (Civil Court). Please contact Self-Help Services for filing options or instructions.

When a *Petition for Change of Name* has been filed for a child by one parent and the other parent, if living, does not join in consenting to the name change, the petitioner must have a notice of the time and place of the hearing or a copy of the *Order to Show Cause* served on the other parent not less than 30 days prior to the hearing under Code of Civil Procedure section 413.10, 414.10, 415.10, or 415.40.

If a petition to change the name of a child has been filed by a guardian, the guardian must (1) provide notice of the hearing to any living parent of the child by personal service at least 30 days before the hearing, or (2) if either or both parents are deceased or cannot be located, serve notice of the hearing on the child's grandparents, if living, not less than 30 days before the hearing under Code of Civil Procedure section 413.10, 414.10, 415.10, or 415.40.
