Self-Help Center

Overview

The Self-Help Centers are open during regular court hours from 8:00 a.m. until 5:00 p.m. These centers provide free procedural assistance to people who do not have attorneys and are representing themselves. Services are limited to neutral procedural assistance. **No legal advice is provided**, no attorney/client relationship is created and there are no private consultations. Bring your case number, a BLACK pen, paper, copies of court documents and any evidence you want to present to the court.

Self-Help Center Workshops:

Individual workshops are offered on a "first-come, first-served" basis. For The Divorce workshop series, you must complete the "Disso I" workshop and you will then be given appointments for workshops II and III. Most classes have homework packets or other requirements that must be complete before you may sign up for the class. Please visit the Self Help Center offering the workshop to determine what documents are necessary before you arrive for class. There are no workshops on court holidays. Classes are for self-represented litigants only.

FAMILY LAW

Divorce Workshops at Lamoreaux Justice Center – 3 WORKSHOP SERIES

- How to Start a Dissolution (Divorce), Legal Separation or Nullity of Marriage ("Disso 1")

 - English y Español: Any Friday that the court is open before your hearing

NOTE: You must attend "Disso I" in order to qualify to attend the second ("Disso II") and third ("Disso III") workshops. Workshops start on time, late registrations will not be permitted.

How to Answer an Unlawful Detainer (Eviction) at the Orange County Public Law Library

CRIMINAL

How to Clean Up Your Criminal Record (Expungments)

- If you were convicted of certain infractions, misdemeanors or felonies in California that resulted in jail time, probation, and/or fines (NOT PRISON TIME), you may be eligible to clean up your criminal record.
- If you were convicted in Orange County and successfully completed all the terms
 of your sentence, you will receive instructions on completing the local Orange
 County Superior Court *Petition* form.
- Only the first 10 people will be admitted to the workshop.
- Please bring to the workshop: Your California criminal record(s) from the court(s) in which you were convicted **OR** your California Department of Justice Rap Sheet.
